What We'd Like To Do



How will it help?

- Warm building all year round, which doesn't need someone coming in an hour early in winter to switch the heaters on (!)
- Extend the life of the floor and improve its appearance

- Better visibility for projector screen, and removes the need for the worship leader to wear sunglasses! We'll be using the screen more if covid-19 means we can't share hymn and service books.
- Better seating for people who need a bit more help getting up and down
- Potential for inspiring and colourful displays, banners and artwork to brighten up the building and improve the worshipful atmosphere.
- Better storage and shelving, adapted to our current needs.

All this will improve the church both as a place of worship and prayer, and make it a more welcoming and accessible space for the community, with more scope for us to use it in mission and outreach.

What will it cost?

The total cost will be £12,500. Most of this is the new heating system, followed by the floor and the blinds. We've some money set aside already, so if we can raise a further £10,000 we'll be able to all this in July.

We're holding a Gift Day on Petertide, 28th June, to try to raise the funds we need. Please do pray and reflect over whether you would be able to support these important works. We recognise that during lockdown some people will have faced more financial struggles, whilst others have saved money, so please give as you can, not as you can't! Every contribution helps – God provided nearly £1m for the Community Centre, so we have faith that He can provide £10,000 for our worship centre, St. Peters church building.

How can I give? There are 4 options

1. Directly through the bank – St Peters bank details are on the next page. We will treat any one-off gifts directly to the St. Peters account between 21st and 30th June as donations to the Gift Day fund.
2. At the church building – St Peters will be open 2-3pm on Sunday 28th June for any offerings. If you also want to bring Lent boxes, Sunday envelopes, or any regular giving which you have been setting aside, we can safely receive that too, and that will be very helpful!
3. Collected from your house. The Church Wardens and Treasurer are happy to pick up gifts in person, to save you having to make a journey. Please let Caroline Turner 474038 or Frances Croxford 415340 know if you would like this service.
4. Directly through the Givt mobile phone app on the 28th June
